## Dear Parents,

It may please be noted that The Director of Education, Govt. of NCT of Delhi has issued directions to all the recognized Un-aided Private Schools in the NCT of Delhi for implementation of the recommendations of the 7<sup>th</sup> Central Pay Commission under Central Civil Services (Revised Pay)Rules, 2016 w.e.f. 01.01.2016 vide order No.DE/15(318)/PSB/2016/19786 dated the 17/10/2017.

For compliance of the above said directions, Tuition fee hike is necessary to be made, keeping in view the financial position of our Institution, as the staff has to be paid revised salary and arrears etc. w.e.f. 01.01.2016.

Though the proposed increase in tuition fee is insufficient to meet the enhanced financial liabilities, we are implementing the decision of Delhi Govt. for the present, without prejudice to our right under the law, as to avoid undue financial burden on the parents.

As per the guidelines issued in the above said order of the Director of Education, the Tuition Fee Arrear for Classes I to XII will be as follows:
