Subject: Fee Chargeable For 2021-2022

Dear Parents,

Please note:

It is with reference to the Directorate of Education Orders dated 18.04.2020 and 28.08.2020 whereby the schools were allowed to charge Tuition Fee only. The Annual Charges/Development Fee were deferred to be charged after the Lockdown period been over, which was enforced due to Covid 19 Pandemic. This matter was challenged by the schools before the Hon'ble High Court of Delhi. The Hon'ble High Court of Delhi by its order 31.05.2021 struck down both the orders of 18.04.2020 and 28.08.2020 of the Directorate of Education and allowed the schools to collect the Development Fee and Annual Charges alongwith Tuition Fee for the year 2020-21 and 2021-22. That the appeal preferred by the DOE against the said High Court Order stands dismissed by the Hon'ble Supreme Court by its order dated 28.06.2021. In the light of High Court's decision the school has decided to grant general concessions/rebates to all students to the extent of 15% of Annual Charges as well as Development Fee for 2021-22 alongwith the other concessions / rebates. Accordingly, the **Revised Fee Structure for the year 2021-22** is available on the website of school dated 29.06.2021.

It may please be noted that the school has collected Tuition Fee on account, from April to June 2021 (for 2021-22) due to the pendency of the fee issue before the Court. Now the issue being settled details of fee chargeable for all classes is given hereunder. So far as Annual Charges and Development Fee referable to April, May and June 2021 is concerned, the same is allowed to be paid in Nine Installments from July 2021 to March 2022 for the sake of convenience of parents, accordingly calculations are made, presented hereunder:- Fees are to be charged for 12 months.
